

FOURTH QUARTER COMMENTARY

The Robinson Tax-Advantaged Income Fund (the “Fund”), as measured by the Fund’s Institutional Class (ROBNX), returned 5.88% in the fourth quarter of 2022, leading its benchmark, the Bloomberg Short-Intermediate 1-10 Year Municipal Bond Index, which returned 2.87% for the quarter. For the full year the Fund was down 8.79% versus the benchmark’s negative 4.51% return. Following is the fourth quarter and full year attribution analysis for the Fund relative to its benchmark index:

The Fund seeks to neutralize the impact changes in risk-free interest rates may have on the underlying holdings of the tax-exempt closed-end funds (CEFs) it holds. The Fund does this through carefully weighted short positions in various US Treasury bond futures contracts. The net result is to isolate, as much as practical, the inherent credit spreads of the underlying investment grade portfolio of municipal bonds. The Fund’s performance benefited from that strategy in the fourth quarter, as credit spreads in the underlying municipal bond market narrowed during the quarter. While municipal bond yields declined 0.49% for the quarter (0.83% on a taxable equivalent basis), Treasury yields actually increased 0.05%. That’s a huge reversal of the widening trend that has been in place for much of the year. For all of 2022, municipal bond yields increased 2.44% (4.13% on a taxable equivalent basis) while Treasury yields increased 2.95%. The widening trend in tax-exempt closed-end fund discounts also began to reverse itself late in the fourth quarter. Discounts narrowed 2.4% in the last three trading days of the year. As a result, they narrowed 0.33% for the fourth quarter; but, for the full year CEF discount widening was a 7.34% reduction on the Fund’s annual return.

The Fund now has the ability to invest in ETFs and/or open-end tax-exempt funds when we believe it prudent. At present, with tax-exempt CEF discounts for the entire universe at around -10%, we are fully invested in CEFs; but, for much of the first half of the year we had less than 50% exposure to CEFs as discounts were practically non-existent at the beginning of 2022. As a result, our security selection was highly additive to the Fund’s overall return for the year as we avoided at least half of the discount widening that occurred in the first three quarters of the year.

The municipal bond market, as measured by the Bloomberg Municipal Bond Index, is coming off its worst year since 1981. Unhedged tax-exempt closed-end funds, as measured by the First Trust Municipal Closed-End Fund Total Return Index, were down 24% in 2022—the worst year ever in the index’ 16-year history. With the Fed nearing the end of its rate hiking cycle, there appears to be some attractive bargains in the deeply battered tax-exempt closed-end fund market. Following are our top 5 reasons for WHY NOW for the Robinson Tax-Advantaged Income Fund in these challenging times:

- 1. Income:** the Fund’s distribution yield divided by its net hedged duration suggests it can withstand another 2% rise in rates before completely eroding the income stream, whereas the Bloomberg Municipal Bond Index can only withstand a 0.50% rise in rates before its income has been wiped out.
- 2. Upside Potential:** the weighted average discount of the CEFs held in the Fund is -10.4%--the historic average discount for those same funds is -4.7%.
- 3. Inflation:** the Fund’s hedging strategy is designed to neutralize the negative impact higher interest rates could have on bond prices.
- 4. Sustainability:** the Fund’s hedging strategy allows it to potentially generate higher income and monetize discounts whether rates are rising or falling.
- 5. Flexibility:** the Fund’s ability to increase or decrease CEF exposure as conditions warrant, is a powerful tactical trading tool that should continue to enhance the Fund’s overall security selection.
